**WAIVER**

### WAIVER OF CLAIMS

I, \_\_\_\_\_, of legal age, single/married, \_\_\_\_\_ (nationality) \_\_\_\_\_, hereby declare that I am physically, emotionally, and legally fit to travel and participate in the CCF Steps of Paul Bible Study Tour from March 18 to April 2, 2024, a total of sixteen (16) days in Greece & Italy.

In the event that my condition changes, my personal travel insurance will cover benefits that will address illnesses and conditions that are not pre-existing. I have informed the tour organizers, Christ's Commission Foundation, Inc. (CCF) of this matter. Should my physical condition require that I be confined in a hospital, be held by immigration authorities, or denied boarding by the airline, the remainder of my tour will be forfeited without any claim for rebooking or refund. I understand that CCF, Inc. will make every effort to assist in the situation, but the final authority will be the doctors, immigration/airline officials, and/or concerned authorities. If my condition further delays the whole group from the tour schedule, I will promptly coordinate with the tour operator and arrange for my repatriation back to the Philippines at my own expense.

Further, I understand that while CCF will do its utmost best to ensure the health condition of the participants immediately prior to the tour, in no way can it guarantee the actual medical condition of a participant or prevent exposure or infection to contagious disease from a fellow participant or from the other persons in the areas visited during the Tour.

I understand that my participation is on voluntary basis and I bear personal responsibility for my health and safety, and that CCF and/or any of its personnel shall not be liable civilly, criminally, or administratively in cases of hospitalization, disease, death, injury, damage or loss of personal property or any other untoward incident, from causes such as, but are not limited to: accidents of whatever kind, war, riots, insurgency, acts of terrorism, fire, flash flood, adverse weather conditions, earthquake, lightning, explosion, gunfire, strikes, lockouts, quarantines or lockdowns, acts of police, state or governmental action, infectious disease, poisoning, extortion, theft, robbery, physical altercation, homicide, sexual harassment, sexual crimes, animal attacks or animal bites which may arise in the course of this Tour. I, or any other person acting in my interest, hereby waive any and all claims against CCF and/or any of its personnel in such cases. Further, in case of illegal detention or kidnapping, CCF and/or any of its personnel shall not be responsible for the payment of ransom or any other amount that may be demanded by the abductors or any other proceeding before any court or government agency.

Finally, I understand that voluntary cancellations due to Covid-19 sickness (mine or any in my traveling party), pandemic escalations, and failure to meet Covid-19 travel and safety protocols and/or vaccine requirements (current and/or updated at any point in the tour) in Greece and Italy, will be subject to the cancellation terms on the Terms & Conditions form.
