



STEPS OF PAUL BIBLE STUDY TOUR

TERMS & CONDITIONS

A. PAYMENT REQUIREMENTS

1. A reservation fee of **\$2,000** on or before **November 30, 2025**, **\$1,000**, is non-refundable but transferable
2. 2nd payment of **\$2,000** due on **December 19, 2025**
3. Final payment of **\$1,690** due on **January 15, 2026**
4. **Delayed payments shall be subject to a late fee of \$5 per person/day.**
5. **CCF reserves the right to cancel bookings if there is non-payment.**

B. COSTS, INCLUSIONS & EXCLUSIONS

Included: 10-night cruise with outside on twin sharing and full board meals; 5-star hotel accommodations with daily breakfast and dinner in Athens & Rome; Athens-Rome flight; entrance fees to all tour sites; luxury air-conditioned buses with licensed English-speaking tour guides; gratuities for all hotels, guides, bus drivers and hotel staff

Not included: **Manila-Athens, Rome-Manila airfare;** passport and visa fees; travel insurance; personal expenses (extra meals, mini bar, phone calls, business center fees, laundry, etc.); hospitalization and medical expenses not covered by your travel insurance; transportation during free time, extension tours; business class, room, and cabin upgrades; airport transfers for those not traveling with the group; and single occupancy. The list is not exclusive. All other provisions not included are deemed excluded.

C. ACCOMMODATIONS

1. All accommodations will be twin-sharing, with rooms containing two beds. Participants requiring one double bed should specify the request at registration.
2. If a single room is preferred, an add-on rate of **\$2,500** will be added.
3. If a single person traveling alone wishes to share a room with another person of the same sex, please indicate in the registration form that he/she is allowing the organizers to assign a roommate to him/her.

D. CANCELLATION PROCEDURES & CHARGES

- The \$1,000 deposit is forfeited when a participant cancels his/her booking. This amount, however, may be assigned to someone else until **December 30, 2025**.
- After deposits and payments are made, cancellation and/or changes in your tour arrangements will warrant charges according to the following time frame:

Receipt of cancellation notice from:	
Before November 30, 2025	\$1,000 deposit
November 30-December 16, 2025	\$2,000
December 17, 2025 to January 12, 2026	60% of the tour cost
January 13 to March 9, 2026	90% of the tour cost
March 10 to March 17, 2026	100% of the tour cost
Tour cost = \$5,690	
Single Occupancy Tour Cost: \$8,190	

- Please complete your cancellation request in writing with accompanying medical certificates (if applicable) stating your reason for cancellation and submit them to the CCF office before the departure date.
- Refunds will only be made available at the CCF office thirty days after the tour group's arrival.

E. NO SHOW/UNUSED SERVICE/REFUNDS

No refunds will be granted for unused services, missed meals, or ungranted requests that would have otherwise been free and already included in the package price.

F. CLAIMS & ADJUSTMENTS

Participants must immediately contact the CCF representative on the tour should any problem arise during the trip so that we can resolve it before it escalates.

G. RESPONSIBILITY

Christ's Commission Foundation, Inc. (CCF) is an intermediary between contractors (airlines, guides, hotels, transport companies, etc.) and the participant. It cannot assume responsibility or liability for any loss, injury, delay, accident, or irregularity that may occur while carrying out the services of the contractors. The participant agrees that Christ's Commission Foundation, Inc. shall not be liable for any damage, loss (including personal injury, death, and property loss), or expense occasioned by any act or omission of any supplier providing tour services or any insurer or insurance of any other person.

The payment of deposit and a signature hereunder constitute a contractual agreement between CCF and the participant and represent consent to all provisions in the Terms and Conditions of this tour package.
